SECTION 2.19. APPLIED FOR BY LODGE: Subject to other provisions of the Constitution and By-laws of the Grand Lodge of South Dakota, A.F. & A. M., By-Law Section 2.19 authorizes a Constituent Lodge to request a temporary change in the date, time and/or place of a Stated or Special Meeting. This request must be submitted in writing to the District Master in advance and reported to the Jurisprudence Committee for review. Any request to a District Master for the following reasons is not proper; the below issues must be submitted to the Grand Master if it would result in the following:

- (1) Balloting on a candidate at other than a Stated Meeting, prohibited by Section 4.95;
- (2) Balloting on a petition fewer than two weeks after the petition was referred to the Committee on Investigation, prohibited by Section 4-96;
- (3) Conferring more than one degree upon the same candidate in fewer than seven days, prohibited by Section 4.113, and;
- (4) Convening (formal opening and closing in any degree) a Lodge on Sunday, except for funeral purposes or public ceremonies, prohibited by Section 4.20.
